The remaining five are being restructured, although they are neither deleting nor adding any significant areas of expertise. Effectively, three current fields are being restructured into two new fields, and two current fields into three new fields, to better reflect the range of current research expertise of MIE faculty. The fields are not used as curricular pathways and do not have discrete Learning Outcomes.</p> <p>The new fields are: Advanced Manufacturing and Materials Engineering; Applied Mechanics and Design; Biomedical Engineering; Energy and Environmental Engineering; Human Factors/Ergonomics; Information Engineering; Operations Research; Robotics, Mechatronics and Instrumentation; Thermal and Fluid Sciences Engineering.</p>	05/01/2013
